Mayor Murphy made a motion to open the public hearing regarding Local Law #1 of 2024 at 7:02pm, seconded by Trustee Manahan. All board members voted aye and the public hearing was opened.

Mayor Murphy explained that the purpose of the public hearing was to allow all interested parties the opportunity to be heard regarding Local Law #1, which would establish a moratorium on land use approvals in the Village Center of the Village of Marcellus until multiple land use regulations are updated and codified, including the Village's comprehensive plan, the design standards for the Village Center, and the Village Code. Details of the proposed law, as well as copies of supporting documents are on file at the office of the Village Clerk for public inspection.

Mayor Murphy turned the floor over to Village Attorney Jeffrey Brown, who explained the Local Law in detail, provided information regarding the events leading to the proposal of the Local Law, and provided answers to questions submitted by a Resident to the Village prior to the hearing. Attorney Brown also stated that the Village was in receipt of the response from the Onondaga County Planning Board, to which the Local Law was submitted for Administrative Review. The OCPB responded with "No Position with comment," and offered the following comment: "The Village is encouraged to update its code to reflect the type of development it wishes to see in the Village Center and that will strengthen and provide long lasting value in this important Strong Center as identified in Plan Onondaga"

Mayor Murphy then opened the floor to the public, and stated that each speaker was allowed 3 minutes to comment. There were 23 speakers, many expressed oppositions to the moratorium and a few expressed their support.
